#### 1. Confirmation of the minutes of the last meeting held on 04.05.2019

#### 3. Discussion on the implementation of new PCI syllabus for third year B. Pharm.

As the R.T.M. Nagpur University implemented new PCI syllabus, the practical difficulties arising for its implementation to third year were discussed by the program committee. Accordingly the requirement of books, journals, chemicals and instruments/equipmentsfor regular practical & for research, and the application form in the prescribed format for the approval of animals for research purpose were invited from the staff members. The meeting of the Institutional animal ethical committee will be called for getting approval for use of animals. Policies were decided for conducting the internal examinations.

#### 4. Preparation of academic calendar and updation of course file

The chairman of the committee asked Dr. M.P. Puranik for the preparation of academic calendar for A. Y. 2019-20. All the HODs are asked to monitor the updation of course file of all the teachers in their respective Departments.

### 5. To decide the policy for increase in M. Pharm. admission.

Since last 2 to 3 years, M. Pharm admissions were short with respect to the sanctioned intake. Hence it was instructed to the admission committee and all the faculty members to motivate the students for admission in M. Pharm.

### 6. Discussion on the implementation of induction programme for first year students.

According to the circular of AICTE, Institute has decided to implement the induction programme for first year students. It was decided to train two faculty members of the Institute by joining training programmes of AICTE for this year. For this, an Induction programme committee will be established in the Institute and the members of this committee will train the students.

## 7. To implement the AICTE mediated Government schemes in the institute

The central Government has launched many schemes which were operated in all Institutes through AICTE. Some of the schemes were already implemented and it was decided to initiate the new schemes from this session so as to increase the extra-curricular activities of the students.
