During the meeting, review of the minutes of last meeting along with Action Taken Report was taken up by the Member Secretary of IQAC. The activities for the organization of SPER 2019 conference was already assigned to the staff members. The progress of their work, any requirement and suggestions were discussed in the meeting. The detailed discussion on the various quality related parameters decided in the meeting dated on 27.04.2018 was carried out and are briefed below.

It was decided to start the even semester from the last week of December/first week of January. New PCI syllabus is implemented for second year of UG. Program committee constituted according to new PCI syllabi is responsible for smooth implementation of syllabus.
6	Internal Resources generation	Some Industrial projects were received to pharmacology department. Consultancy services are also going on by Quality Assurance and Pharmaceutics Department. It was decided to confact more industries so that more number of projects and hence more internal revenue will be generated
